Dismantle and Move-Out Information

All exhibitor materials must be removed from the exhibit facility by **8:30pm on Thursday, March 10, 2022**. Any materials remaining in the facility will be re-rerouted via AES's choice or returned to warehouse to await disposition at exhibitor's expense.

To ensure all exhibitor materials are removed from the exhibit facility by the Exhibitor Move-Out deadline please have all carrier's check-in by **4:00pm on Thursday, March 10, 2022**.

Outbound Freight Shipments

- TS Shipper is the preferred freight carrier for this show and will be available during show hours at the AES Service Desk. All material handling, return to warehouse, and/or storage charges must be settled before a shipment will be released to <u>any</u> carrier. To/From shipping labels and Material Handling Agreements will be available at the AES Service Desk prior to the close of show.
- If you choose to use a carrier other than TS Shipper, such as Fed Ex and UPS Parcel, you will need to make the pickup arrangements prior to departure. Please reference the check-in and move-out times above. Please note some carriers, including UPS and FedEx will require carrier specific shipping labels and must be pre-printed and attached to your shipment in order for them to pick up and accept your shipment. AES will not be available to provide carrier specific labels.
- Any shipments left on the show floor after the carrier check-in time above will be re-routed via the show carrier at the Exhibitor's expense. Shipping fees will be invoiced to the master account on file.

Time Saving Hints

- Arrange your outbound carrier early. Our Service Desk will be available during all show hours for your assistance.
- Fill out, sign and return your MHA to the Service Desk once your shipment is packed and labeled.
- Remove old labels and tags.
- Keep all copies of shipping documents for tracking purposes.
- AES is happy to provide printed, non-carrier specific shipping labels. Please visit our Service Desk.

Excessive Trash and Booth Abandonment

• Any excessive trash which consists of display materials, carpet, padding, crates and/or pallets will be disposed of and charged both a handling fee and disposal fee during move-out.
